SPECIAL DISTRICT 7
CONGRESSIONAL GENERAL ELECTION

The Williamson County Election Commission is hereby publishing notice of the early voting period for the December 2, 2025 Special District 7 Congressional General Election. The law allows any eligible and qualified voter residing in the 7th Congressional District to cast a ballot by personal appearance at the Election Commission Office located at 405 Downs Blvd, Franklin, Tennessee, or at any designated early voting satellite location during the period beginning twenty (20) days prior to the election and normally ending five (5) days before the election (T.C.A §§ 2-6-102(a) (1) and 2-6-103 (a) (1). **Offices closed on Thursday, November 27 & Friday, November 28** for State and County observed Thanksgiving holiday. Therefore, early voting will begin and end on the following dates:

PROCEDURES FOR VOTING BY MAIL (T.C.A § 2-6-202)

If you meet one of the conditions allowed by law to vote by mail (visit www.williamsonvotes.net to see if you qualify), you must request a ballot in writing over your signature. The request may be made as much as ninety (90) days in advance of an election and no later than ten (10) days prior to an election (November 22, 2025). The request may be emailed to Absenteevote@williamsoncounty-tn.gov or mailed to the Election Commission Office at 405 Downs Blvd, Franklin, TN 37064. A registered voter eligible (person hospitalized within twenty days of the election and unable to vote in person on Election Day) to request the service of an Emergency Registrar shall make such a request not more than twenty (20) days (November 12, 2025 at 4:30 P.M.) before the election and no later than the opening of the polls on election day at 7:00 a.m.
