NOT SOFT ON CRIME. SMART ON TREATMENT AND RECOVERY.

The Kentucky State Police started the Angel Initiative in 2016 with one main goal: **To Save Lives.** Since it's implementation, the Kentucky State Police placed over 180 individuals, seeking assistance, in treatment programs across the state.

The Angel Initiative is a proactive statewide assistance program offering assistance to Kentuckians battling substance dependency and addiction. Available at all 16 Kentucky State Police Posts, any persons experiencing substance dependency and/or addiction can come to **ANY** Post for assistance locating treatment. No questions asked.

Kentucky State Police will continue to pursue and prosecute those trafficking illicit and prescription drugs, but if you find yourself needing assistance in escaping the grip of substance dependency and addiction, we are here to help.

WHAT TO EXPECT WHEN YOU ARRIVE AT POST

You will be asked to provide a photo ID or other means of identification. It is also helpful to have a copy of your insurance information but lack of insurance does not disqualify you from participating. There are many facilities that accepted non-insured individuals.

You will be asked to sign a Participant Agreement Form granting permission to conduct a records check and submit to being searched.

If you have any drugs and/or drug paraphernalia (needles, pipes, etc.) on your person, you will not be charged, jailed, or investigated. The drugs and/or paraphernalia will be confiscated and destroyed as soon as possible.

You will be asked to provide information during the intake screening to determine the best treatment options for you. The Angel Coordinator will work quickly to locate a treatment facility to best meet your needs.

DISQUALIFIERS FOR THE PROGRAM:

An outstanding arrest warrant

- A non-extraditable arrest warrant in another jurisdiction
- The participant is a registered sex offender in any state
- There is reasonable belief that the Angel Coordinator or others could be harmed by the participant.
- An unaccompanied minor

ANYONE VOLUNTARILY ENTERING A KENTUCKY STATE POLICE POST SEEKING ASSISTANCE WITH SUBSTANCE DEPENDENCY AND ADDICTION WILL BE IMMEDIATELY SCREENED FOR PARTICIPATION IN THE ANGEL INITIATIVE.



WHAT ARE THE OBJECTIVES OF THE ANGEL INITIATIVE?

Kentucky State Police seeks to forge collaborative partnerships within the community to address substance dependency and addiction and to reduce and prevent the threat of overdose and overdose death.

After a screening is completed, any eligible persons seeking assistance voluntarily will be treated professionally and compassionately during the entire process in obtaining treatment without fear of prosecution.

The Angel Initiative does not apply to those persons seeking to complete court-ordered treatment, to fulfill sentencing obligation, or those persons encountered during regular law-enforcement duties.
