Comes the Affiant after being duly sworn states the following:


My name is Charles Tidwell. I am employed as a Deputy Sheriff with the Calloway County Sheriff's Office.

On September 26, 2018 the Calloway County Sheriff's Office received information that a homicide had been committed at 18 Heather Lane in Calloway County. Upon speaking with the reporting party, Jennifer Wolfe, she informed Calloway County Dispatch that her niece, Tammy Allen of 18 Heather Lane told her that she had killed her ex husband and put his body under her trailer at 18 Heather Lane.

A search warrant was obtained and executed at 18 Heather Lane, and the body of Jimmie Craig Taylor was found under the mobile home at that address.

Deputies Nicky Knight and Jon Michael Hill went to Jackson, Tennessee and interviewed Tammy Allen at the CID annex building. During that interview Tammy Allen told the Deputies that she and Jimmie Craig Taylor had been in an altercation and she had shot him twice in the head.
