STATEMENT BY KENTUCKY BLACK FAITH AND CIVIL RIGHTS LEADERS ENCOURAGING COMMUNITIES TO CONTINUE TO "STAY AT HOME"

We, the undersigned, have joined together to state our unequivocal and firm support for the "Statement by National Black Faith and Civil Rights Leaders Encouraging Communities to Continue to 'Stay at Home' in States Lifting Orders" (

naacpldf.org/press-release/statement-by-national-black-faith-and-civil-rights-leaders-encouraging-communities-to-continue-to-stay-at-home-in-states-lifting-orders/). We further state our support for Governor Andy Beshear and the steps and actions he has taken to keep all citizens of the Commonwealth safe and informed.

Based on the best data available in Kentucky, Black people make up 8.3% of the state's population yet we have accounted for 14% of those testing positive for COVID-19 and 22% of COVID-19 deaths. In Louisville, Blacks make up 23.5% of the population yet we have accounted for 27% of individuals testing positive for COVID-19 and 20% of the COVID-19 deaths. In Lexington Blacks make up 15% of the population but 30% of the individuals testing positive for COVID-19 and 55% of the COVID-19 deaths. The virus is ravaging our Black communities.

We find it alarming, reckless and counterproductive, that given these numbers and their impact on the Black community that the Attorney General of the Commonwealth of Kentucky, Daniel Cameron, would state and take steps that align himself with actions which have been, will be and are detrimental to the Black community.

Further, it is appalling, insensitive, and disrespectful that the Attorney General would make this announcement as to his intentions on the steps of the Capitol flanked and buttressed by an individual who has demonstrated his lack of judgment and regard, in promoting and supporting the use of "blackface" in his church activities and presentations, and only apologized after being publicly discredited.
