Very unsteady on his feet and very slurred speech. A strong odor of alcoholic beverage was coming from his person. HGN- lacked smooth pursuit/ HGN prior to 45 degrees and distinct HGN at max deviation. Walk and turn- stepped off line several times, used arms for balance, failed to touch heel to toe more than twice. OLS- Could not complete test.
