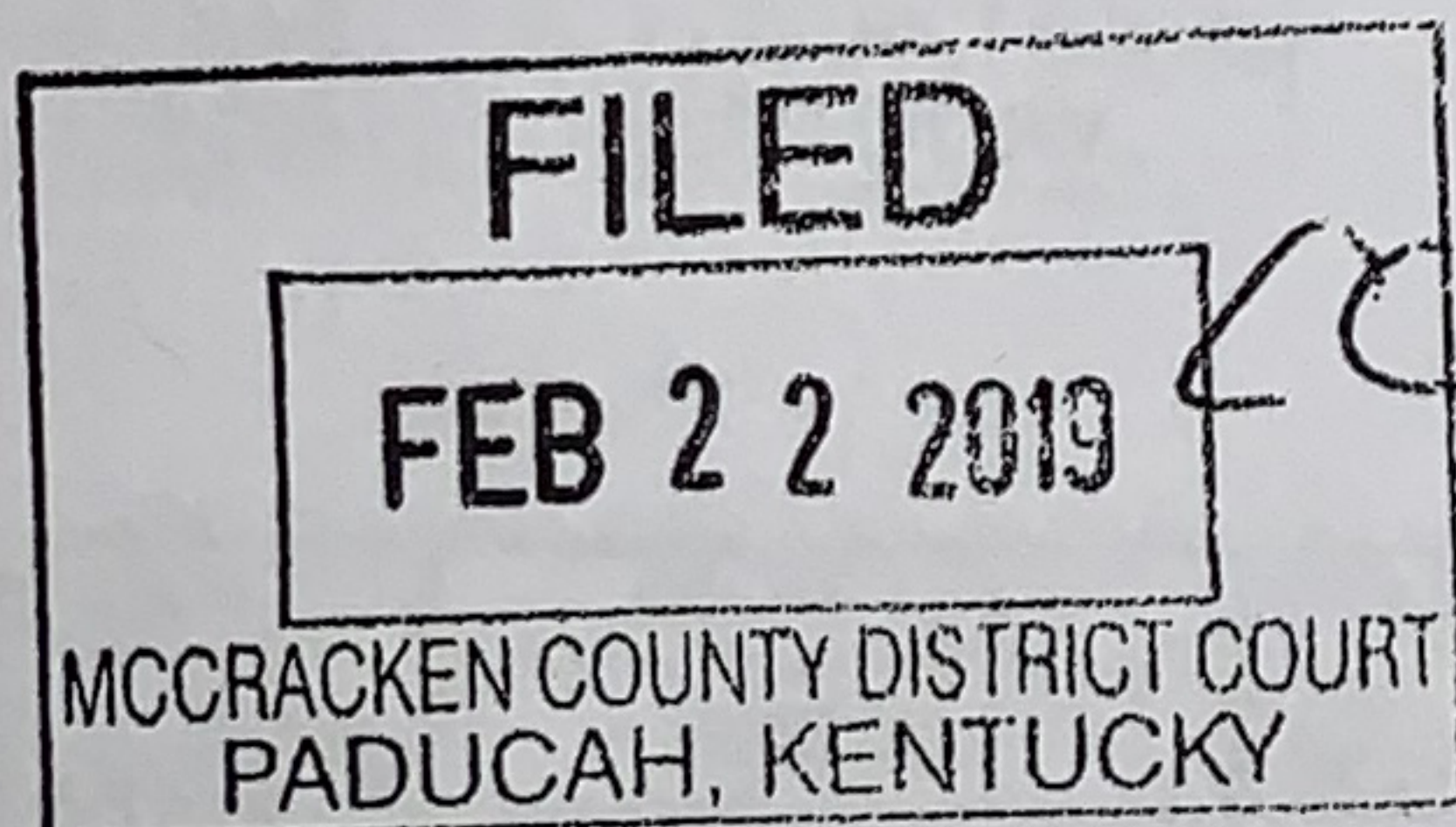

The Affiant, Captain Norman, states that on 7/1/2018 in MCCRACKEN County, Kentucky, the above named defendant unlawfully: On February 6, 2019 detectives with the McCracken County Sheriff's Office began investigating inappropriate communication between a teach, Daniel Edwards, and a current student. Edwards is and was a teacher at McCracken County High School. During the investigation, detectives learned that Edwards may have inappropriately communicated with a recently graduated student in June or July of 2018. This affiant spoke with the former student. The former student stated that she received a message from Edwards, out of the blue, asking her for a naked picture. She stated that this was not part of an ongoing conversation and that she had not recently spoken to Edwards. She stated that her relationship with Edwards was only one of a student/teacher and athlete/coach. She stated that the message asking for a naked picture was weird and unwanted. She stated that she asked Edwards where his wife was and Edwards did not message her again. She is unsure how Edwards knew how to contact her. She was in and residing in McCracken County at the time.
