COUNT 9: Ten (10) years, concurrent with all other counts.

COUNT 10: Twenty (20) years, concurrent with all other counts.

COUNT 11: Ten (10) years, concurrent with all other counts.

COUNT 12: Twenty (20) years, concurrent with all other counts.

COUNT 13: Ten (10) years, concurrent with all other counts.

COUNT 14: Ten (10) years, concurrent with all other counts.

COUNT 15: Ten (10) years, concurrent with all other counts.

COUNT 16: Twenty (20) years, concurrent with all other counts.

Counts 3 through 16 are to run as noted above for a total of 70 years to serve, that time to run concurrently with Counts 1 and 2 as mandated by statute for a total sentence of LIFE in the state penitentiary.
