JUL 1 0 2018 Complaint MCCRACKEN COUNTY DISTRICT COURT PADUCAH, KENTUCKY The Affiant, Jody Cash (KY STATE POLICE, POST 01 1099), states that on 6/3/2018 at 14:00 in MCCRACKEN County, Kentucky, the above named defendant unlawfully: On July 3rd, I began a joint investigation with BCBS in regards to the possible is a one year old infant who has had multiple fractures noted in his right arm on two separate occasions. The first occasion was September 13, 2017 during a visit to Pediatrician Dr. John Roach for "unable to move shoulder" and "screams when touched". X-rays taken during that visit revealed "small corner fractures at the proximal humerus". The second occasion was June 28, 2018 during a visit to Pediatrician Dr. John Roach for "swollen right elbow". This visit was initiated after bruising/swelling was noted June 4, 2018 and did not fully subside. X-rays taken during that visit revealed "healing fractures of the distal humerus" as well as "probable healing fractures of the proximal ulns and distal radius". On July 3, 2018, Pediatric Orthopedic Dr. Andrew Gregory as well as Dr. Deborah Lowen both of Vanderbilt Children's Hospital, confirmed the presence of multiple corner fractures in right arm, which only occur in young children and are from yanking, pulling, or twisting motion. These type fractures are highly associated with abuse and do not occur with normal infant handling. Dr. Lowen has ruled these fractures to be non-accidental and has stated 1 is the victim of child physical abuse, resulting in multiple fractures of his right upper extremity. She further concluded this maltreatment likely occurred more than once. During an Interview, Dave admitted to pulling/yanking on erm with excessive force on numerous occasions, with the last time being on/near June 3, 2018. Dave knows this date because on June 3, 2018 he also struck the property of the property with moderate force while trying to get through the door. Dave did not disclose this doorway strike to nor to any of the three doctors who had questioned the parents during/after the June 28th visit. Dr. Lowen has been consulted as an expert and has confirmed the doorway strike could be the source of the bruising/swelling noted June 4th, as well as the pulling/yanking with excessive force could be the source of the multiple fractures in the right arm. Dr. Lowen also confirmed blood analysis has not shown any evidence of a medical condition which could be the source of these serious injuries.
