PROBABLE CAUSE:

The complainant is in possession of police reports by Officers Tyler Larsen, Charles Walton, Zachary Burnett, Arthur Jaquish, Dominic Meincke, Wayne Bjorkman, Teagan Velin, and Jacob Olson of the Eau Claire Police Department, Deputies Aaron Ranallo and Samuel Eaton of the Eau Claire County Sheriff's Office, and Investigator Dan Westlund of the Dunn County Sheriff, which form the basis for this complaint.

Investigator Ranallo reports that on April 4, 2025, law enforcement executed a search warrant at 1105 Barland Street in located in the City and County of Eau Claire. 1105 Barland Street is a residence known to law enforcement as a drug house with frequent contacts at the residence for drug related activity.

Investigator Ranallo reports that during the execution of the warrant law enforcement encountered a vast number of persons at the residence, including defendants:

Investigator Bjorkman reports that while executing the search warrant, he encountered Cuykendall in the living room on a couch. Cuykendall was the sole occupant of the couch and was being uncooperative with law enforcement. Investigator Bjorkman gave commands to Cuykendall, who was looking directly at Investigator Bjorkman. Investigator Bjorkman reports that he had heard other officers inform Cuykendall that this was a search warrant. Cuykendall refused to place his hands in the air and refused to remove himself from the couch. Cuykendall then began to reach around himself. Investigator Bjorkman observed Cuykendall quickly lunge his hand under a blanket that was next to him. Investigator Bjorkman fired the 40mm less lethal launcher and struck Cuykendall in the left leg. Cuykendall removed his hand from the blanket and then complied with commands. A knife was located concealed under the blanket. Cuykendall is a convicted felon.

During the search of the residence there were numerous drugs and drug paraphernalia located. Below is a breakdown of contraband/evidence by room as well as listing which person was in which room. All contraband mentioned, unless stated otherwise, was readily observable and would have been known to the occupants of the rooms.

SOUTHWEST BEDROOM - WARK, TREPANIA, BROOKS

- Makeshift methamphetamine pipe found in the southwest bedroom on the main floor by Investigator Bjorkman - field tested positive for methamphetamine by FOS Ranallo.
- Miscellaneous drug paraphernalia found throughout southwest bedroom on main floor by Investigator Bjorkman.

NORTHWEST BEDROOM - NORDLOF, VINCENT, DEGEORGE

- Pill bottle containing three (3) unknown and unmarked pills Found by Investigator Gantt in the northwest bedroom, on the main floor, in a black bag which also contained a prescription bottle for Nicholas Vincent.
- Miscellaneous drug paraphernalia, including one(s) used to inhale controlled substances, found throughout northwest bedroom on the main floor by Investigator Gantt.
- Syringe containing 3cc of liquid found in north bedroom on the main floor, in a cigar box next to the bed by Investigator Sperry field tested positive for methamphetamine by FOS Ranallo.
- Miscellaneous drug paraphernalia found throughout northwest bedroom on main floor by Investigator Gantt
- Container with three (3) THC edible gummies found in northwest bedroom, main floor, in bottom drawer of nightstand by Investigator Gantt field tested positive for THC by Investigator Gantt.

GARAGE - RANEY, DUCKWORTH

- Miscellaneous drug paraphernalia, including those used to inhale controlled substances, found throughout the garage by Investigator Gilbertson.
- Two cats were located in crates stacked on top of each other. CSO Velin reports that the crates smelled strongly of animal stench and the cats had greasy fur, indicating they were not cleaning themselves. CSO Velin also observed some matted fur and noted the overall living conditions were unacceptable. CSO Velin opinioned that Duckworth, who claimed ownership of the cats, was not providing proper shelter for the cats.

CHEVY BLAZER IN DRIVEWAY - RIEBE

- Loaded syringe found by Sergeant Ring in the green Chevy Blazer in driveway field tested positive for methamphetamine by Investigator Bjorkman.
- Scoop straw with gem bag and residue found by Investigator Scholl in a pink backpack, in the green Blazer, along with Lisa Reveron's food pantry card - field tested positive for methamphetamine by Investigator Bjorkman.
- Two gem bags containing suspected methamphetamine residue found in the green Chevy Blazer by Sgt. Ring field tested positive for methamphetamine by FOS Ranallo.

FORD EXPLORER IN DRIVEWAY – REVERON, HESTER

- Two (2) plastic gem bags containing suspected methamphetamine residue found in a red bag with "Chelsea" written on it, found in the 2nd row of the Ford Explorer in the driveway, found by Investigator Scholl - field tested positive for methamphetamine by Investigator Spehle.
- Blister pack containing seven (7) Olanzapine pills belonging to Cody Blasingame found by Investigator Scholl in the red bag with "Chelsea" written on it.
- Rubber container with THC wax (4.69g including container) found by Investigator Scholl in second row of Ford Explorer.
- Plastic tube with metal end with residue found by Investigator Scholl in 2nd row of Ford Explorer field tested positive for THC by Investigator Spehle.
- Two loaded syringes found in red bag with "Chelsea" written on it by Investigator Scholl field tested positive for methamphetamine by FOS Ranallo.

BASEMENT - HORTMAN, HAILE

- Suspected methamphetamine bubble pipe found in the southeast basement bedroom (Hortman's) by Investigator Westlund field tested positive for methamphetamine by Investigator Gantt
- Digital scale found in southeast basement bedroom (Hortman's) by Investigator Westlund.
- Miscellaneous drug paraphernalia found throughout the west basement bedroom occupied by Haile found by Investigator Bjorkman.

LIVING ROOM - CUYKENDALL, EATON, LUEHRING, GEE, GARNETT

- Folding knife found by Investigator Bjorkman on the living room couch under a blanket.
- Small metal tin containing unknown white powder found by Investigator Spehle on floor between living room and southwest bedroom substance not field tested for safety.
- Seven (7) Clonazepam (1mg) pills found in Brandon Gee's right coin pocket of his pants by Detective Larson. Clonazepam is a Schedule IV drug and requires a prescription.

MAKESHIFT BEDROOM IN LIVING ROOM - CHABLE, SHIVER JR.

- Capped syringe with liquid found in the north bedroom on main floor, in bag with Angela Chable's ID found by Investigator Sperry field tested positive for methamphetamine by Gilbertson.
- Syringe containing 3cc of liquid found in north bedroom on the main floor, in a cigar box next to the bed by Investigator Sperry field tested positive for methamphetamine by FOS Ranallo.

MAKESHIFT BEDROOM/LAUNDRYROOM - GARNETT'S ROOM

Investigator Sperry reports that he located a loaded syringe in the east "bedroom," which appeared to be a laundry room, in a Nike backpack on the dryer. The substance inside would later field test positive for the presence of methamphetamine. Investigator Ranallo reports that he was informed that Garnett was staying in this room.

INTERVIEWS

Investigator Westlund reports that he spoke with some of the occupants of 1105 Barland Street. Garnett reported that he and Wark had lived at the residence together for a period of time. Garnett stated he had lived there for approximately two and a half months. Garnett stated that he used methamphetamine. Garnett further reported that he had seen at least six people at any given time utilizing drugs in the house, including "down" (meaning opioid, such as heroin or fentanyl). Garnett added that Eaton was aware of the drug use and that she would typically use drugs with the people in the house. Garnett further stated that people in the house would sell drugs as well.

Investigator Westlund reports that Reveron stated she was sleeping in the driveway in the vehicle because it had broken down and she had no place to go. Reveron advised that she had a "bub," or methamphetamine pipe, in the vehicle, but that it wasn't her pipe.

Investigator Westlund reports that he interviewed Jason Squires on April 7, 2025. Squires had been arrested on March 23, 2025, for possession with intent to deliver methamphetamine. Squires confirmed that he had lived at 1105 Barland Street while he was selling methamphetamine. Squires further stated that there was frequent drug activity at the residence, including residents providing methamphetamine to the owner of the

residence, the defendant Georgia Eaton. Squires reported that other persons at 1105 Barland Street were also actively selling drugs while he was staying there.
