# INTRODUCTION

### Objectives

The Eau Claire County Parks and Forest Department hired the team at Ayres Associates in the summer of 2022 to assist with visioning and master planning efforts for 7 parks and recreation areas within the county park system. These parks include: Lowes Creek County Park, Tower Ridge Recreation Area, Coon Fork County Park, Lake Eau Claire County Park, Big Falls County Park, Harstad County Park, and L.L. Phillips County Park.

The team at Ayres Associates built upon the Eau Claire County Outdoor Recreation Plan (CORP) completed in the spring of 2022 by the Eau Claire County Parks and Forest Department and the West Central Wisconsin Regional Planing Commission. The goal of this master plan document is to provide additional detail to the CORP with a realistic approach from vision to implementation.

### **Scope and Methodology**

The master planning process was broken down into several critical tasks to achieve well informed and strategic park plans for Eau Claire County.

### Task 1: Base Mapping

The first necessary task was to create base maps for each of the 7 parks. A solid understanding of the existing conditions and recommendations was developed through studying GIS (Geographical Information System) data and referencing previously completed Eau Claire County Parks and Forest documents (by others).

### Task 2: Park Inventory

Park inventory began with site visits to each of the 7 parks. The Ayres team of experts studied each park and documented observations

"Eau Claire County provides a diverse park system for all people to experience the water, land and forests of Eau Claire County through a connection to nature and recreation 365 days a year." to reference when developing detailed site inventory maps. This thorough understanding of the existing facilities and programming at each park helped to guide discussions and recommendations for improvements. This task culminated in a visioning workshop with the Steering Committee to develop goals and objectives, mission statements, priorities and concerns.

### **Task 3: Park Survey**

Task 3 was a critical time in the master planning process to gather input from the public and stakeholders with the goal to build consensus on a future vision for each park. Conversations continued with the Steering Committee following the visioning workshop. An online survey was also developed and circulated widely through the County website and other platforms. The data gathered from these processes informed preliminary master plans for each park.

### **Task 4: Present Findings**

The preliminary master plans developed with task 3 helped to guide informative discussions with the Steering Committee and various passionate user groups. Feedback from these discussions helped to guide master plan refinement in the last phase of design.

### **Task 5: Park Designs**

One master plan was developed for each of the 7 parks. Accompanying the plan is a mission statement, goals, and existing and proposed park program list. This supporting information helps to develop a unique strategy and sense of place for each park. Plans were reviewed by stakeholder groups throughout the design process and presented to County staff and board for adoption.



# INVENTORY









## **Lowes Creek County Park**

Lowes Creek County Park is a larger park located just south of the City of Eau Claire. The park is popular for it's trail system, particularly for running and mountain biking. The overall forest health is good despite some oak wilt. There are some mature oak and pine trees towards the center of the park on the east side of the creek that are showing signs of mortality. These should be monitored and hazard trees should be proactively manged for safety. The forest would benefit from a non-commercial thinning to promote overall health and minimize future mortality. Buckthorn is a concern at Lowes Creek and should be actively manged with repeated treatments. There are opportunities for prairie restoration and management here, particularly in the clay pit on the eastern side of the park by Highway 93. The park faces erosion issues around the bridge crossing the creek. A long term strategy to mitigate the erosion should be addressed, possibly through alterations to the crown of the road surface to slow the water flow.

## **Tower Ridge Recreation Area**

Tower Ridge Recreation Area is the flagship of Eau Claire County's extensive land system, boasting exceptional trails for horseback riding and cross country skiing. The park's western portion features a remarkable 36-hole disc golf course, serving as both a skills course for skiing during winter and lit trails best for night skiing. The youth ski group, which meets every Monday, has grown significantly, potentially causing parking problems. Privately-run, the southern edge of the park houses a shooting range below a high bluff. Recently built, a contemporary ski chalet, complete with restrooms and kitchen, serves as a welcomed amenity for visitors. Park staff constructed a maintenance building, housing ski grooming equipment, along with a smaller garage for disc golf and ski clubs. Excellent wayfinding is present at almost every intersection of the park, although the eastern half is less utilized due to the nature of public access. Unauthorized ATC use can be found along the trails, but controlling access points is a challenge. Perhaps, obstacles to adjacent properties should be considered. Tower Ridge's forest health is relatively good, but oak wilt is present especially among the vast oak found on the disc golf course. Buckthorn is starting to infiltrate, suggesting that management should consider controlling its spread.





## **Coon Fork County Park**

Coon Fork County Park features a sizeable campground and an 80-acre non-motorized lake with several access points for canoes and kayaks. The western side of the park is underutilized, especially away from the lake. There are a few trails passing through the park and connecting to county land. There is an opportunity here for secluded backpack-only access campsites near the lake. The park is looking for FEMA funding for a storm shelter and trying to identify alternative uses for it to justify investment. A garage for a ski trail groomer is also desired here to help maintain the trails. Camping is very popular here. There is a large firewood yard that should be preserved and encouraged to minimize risk of introducing invasive to the park though people carrying in personal firewood. There is also free wifi available in the campground. The forest is relatively young. Mature jack pine has previously been removed from the park. Oak wilt and other concerns are minimal here due to the young age class. The dam and bridge are a great asset to the park. They serve as an iconic focal point and provide excellent views downstream.





## Lake Eau Claire County Park

Lake Eau Claire County Park is a small park located on the Eau Claire River. It is very underutilized and predominately used by locals, often for short visits. The old main building has outlived its usefulness and is being considered for removal. Rentals for weddings and other gatherings have decreased in recent years. The park has large areas of grass amongst mature pine and oaks. The County maintenance staff is based at this park so it is logistically easier to maintain. Trees with root damage and signs of rot should be removed before they become a hazard for park users. The park has a well-constructed fishing dock and rock lined shoreline with good accessibility to the river. There is also a large BBQ near the main building. This unique amenity should be promoted for gatherings. A portage should be considered for paddlers recreating on the river. Improvements could be made to the existing portage on adjacent land that is connected by trail. This park could benefit from increased amenities to encourage more usage.






## **Big Falls County Park**

Big Falls County Park is a popular destination due to the beautiful natural features located there. A new parking lot and restrooms were completed this year on the west side of the park. The trails are scheduled to be repaved within the next year. The eastern side of the park is in need of improvements. Direct access to the falls is difficult off the paved paths. An ADA platform should be considered to improve accessibility for the public. There should be some trail maintenance conducted on the eastern side of the park to potentially improve access from that side of the river. There are some sizable concentrations of poison ivy that might be dealt with at that time.



## **Harstad County Park**


Harstad County Park is a quaint park situated on the serene Eau Claire River, boasting 27 primitive campsites and a canoe/kayak landing. Although it is not heavily trafficked, recent attention has been given to enhance the park. A charming playground has been installed near the river, and a pavilion is slated for construction. The original shelter has already been dismantled to make way for this new addition, and power has been connected to the pavilion location. Initially, management considered using solar power to energize the pavilion, but ultimately dismissed the idea due to maintenance concerns. The park also features a ball field that has been underutilized, raising the possibility of it being removed. Subsequent improvements include establishing an archery range, introducing a group campsite, or creating a walking trail that spans the entire park. The restroom facilities also require modernization and accessibility upgrades. Connection to adjacent Lake Eau Claire County Park is also being contemplated, requiring public land easements. Notably, the existing canoe/kayak landing remains the park's biggest draw, necessitating improved parking in the riverfront area. The park is predominantly forested with majestic pine and oak trees, with some swamp white oak and sycamore trees in the improved area near the river.





## L.L. Phillips County Park

L.L. Phillips County Park, enveloped in dense forestry, offers a charmingly intimate setting for primitive camping. The park boasts a meandering trail network and a petite open campsite/day site spot nestled in its northern reaches. With the potential to expand camping options and upgrade the group site, the park also recently erected a delightful pavilion. While the parking lot boasts an informal and snug aesthetic, there is room for improvement in visibility and accessibility, particularly in aiding law enforcement monitoring. The riparian area of the park lends itself to unique interpretive signage that could foster a deeper sense of connectedness to the park's abundant attractions. The forest itself flourishes, primarily consisting of robust oak, pine, and additional hardwoods. To ensure enduring health and vitality, thinning of some of the pines is duly recommended.

# ASSESSMENTS

Three different engagement strategies were used to gather stakeholder and public input for the Eau Claire County Parks master planning process. Outreach included an online survey, user group discussions, and steering committee feedback. The following sections will discuss the main outcomes and lessons learned.

### **Outreach Survey**

The outreach survey was circulated by the Eau Claire County Parks and Forestry department through the County website, social media and other efforts. The survey provided valuable information for the master planning process with 146 responses.

### **Key Findings**

Over 75% of the respondents were residents of Eau Claire County and most people were over the age of 34. The highest respondent age group was 35 to 54 years of age, with over 55 years of age following closely behind. The survey results lacked the perspective of the younger generation. Very few respondents visit an Eau Claire County Park daily (4), but many visit weekly. 88% report at least a monthly visit. Lowes Creek and Tower Ridge were reported to be the parks visited most often from the survey results. This could be due to very active user groups at those locations (mountain biking, cross country skiing, horse back riding). Almost 50% of respondents spend about 2 hours at their favorite park. Very few people spend more than 8 hours there. Popular parks mentioned outside the Eau Claire County Park System included: Lake Wissota, Brunet Island, Devils Lake, amongst others. As for biggest challenges, these included funding, maintenance, aging infrastructure and more (see appendix). Modern restrooms and trails were mentioned most as amenities needing improvement. The results on trail activities and overnight camping were fairly split.

### **User Group Engagement**

### **Chippewa Valley Trail riders**

The Chippewa Valley Trail riders is an organization that helps to promote horse trails in the area. According to the interview with a member, Tower Ridge is the post popular destination for this trail use. A map with horse trails is desired for the County Park system. The knowledge is currently only shared by word of mouth. Additional information for water access and trail distance and ride time would be helpful to improve user experience. There could be more promotion of horse back riding on the County website to grow this user group. Trail maintenance is a concern and could be improved.

### Lake Altoona Ski Sprites

The Lake Altoona Ski Sprites is an organized group that advocates for waterskiing and boating in the Chippewa Valley. The group performs on Lake Altoona in the summer months. The team is in need of upgraded amenities to improve the user experience at the park. These improvements include: lighting for evening events, sound booth for permanent audio system, and upgraded restroom facilities. A viewing area would improve the experience for the public who come out to watch a show. Water quality is also a concern for the group and the beach has to close at times during the season due to environmental issues.

### **CORBA Trail Group**

The CORBA trail group serves to promote and maintain biking facilities in the Chippewa Valley. Lowes Creek is the most popular destination within the County Park system for mountain biking and winter biking use. In conversations with group board members, it was understood that there are park updates that would improve the user experience for bikers. These include: paving the west side parking lot, adding a skills course, a large pavilion for event use, a bike repair station, especially a pump on the west side of the park. Overall, facilities and amenities need improvements at Lowes Creek. The group would like to see professionally designed and built trails. Grants could help assist this endeavor. The group hopes that the Eau Claire County Parks can become a tournament destination for biking.

### **EC Ski Striders**

The EC Ski Striders rely heavily on Tower Ridge and have already helped to improve this park through their help in maintenance and the building of the Ski Chalet. Their continued support is needed at Tower Ridge and additional parks such as Lowes Creek and Coon Fork to help improve and maintain the existing facilities. Their work on wayfinding and signage at Tower Ridge make them perfect candidates to help improve the wayfinding and signage at other parks. When working on improvements to Tower Ridge, this group should be consulted with on a regular basis.

### **Regional Synergies**

A regional inventory and analysis was conducted to study the distribution of county parks across Eau Claire County and all adjacent counties (Chippewa County, Clark County, Dunn County, Jackson County, and Trempealeau County). 49 county parks were identified amongst the region highlighting that there are a vast amount of recreational opportunities for residents in West Central Wisconsin. To better understand the accessibility of the park systems, a 5-mile buffer from municipalities in the region was drawn. (See page 24-25).



A majority of these destinations fall within a 5-mile distance from a municipality. In Eau Claire County, Guettinger Woods is an outlier. The map also communicates that southern Eau Claire County and northern Trempeauleau and Jackson County are lacking in county park resources.

In Eau Claire County, the cities of Eau Claire, Altoona, and Augusta all have parks within 5 miles. Fall Creek also has access, but Fairchild is in a void of county park amenities.

### **Beaver Creek**

Beaver Creek uses Big Falls and Coon Fork for kayaking and fishing classes. There are access challenges with these parks, especially when managing a group of 20 children. Different structures to camp site rental should be explored, including first come first serve in some locations. More entry points along the Eau Claire River would be beneficial. Beaver Creek has a campsite along the river. Butterflies for the butterfly house and pond water for pond water experiments are collected from a nearby County forest. Additional improvement ideas include adding areas within the park system to recreate with dogs.

### **Steering Committee**

The Steering Committee served a vital role throughout the master planning process. They helped to kick the project off with site tours at each of the parks included in the plan. They shared their expert advice and experiences.

The group assisted the design team through a visioning process to develop missions and programming direction for each park. The committee also shared their general expertise on the community and park system. Hopes and concerns for the future of the Eau Claire County Parks were also discussed amongst the group to guide the master planning process.

Additional meetings were held with the committee to discuss design direction. Master plans were shared throughout the process to gather feedback and inform modifications and revisions to the plans. Consensus was built through the committee to best serve the greater Eau Claire County community.

A final master plan review was conducted with the committee prior to the adoption of the master plan by the County Board.



# **MASTER PLANS**

### Process

The master plans were built on a foundation of steering committee visioning and critique. They also incorporated feedback from a successful online survey that received well over 100 responses. It was critical to gather community feedback in order to reflect the most appropriate and highest uses of each park being designed in this process.

The plans emphasize current successes of each location and propose expansions or renovations where necessary in order to improve upon what is already enjoyed. In certain instances, new uses and program are proposed to strengthen interest in a park.

### Mission

Mission statements were written for each of the 7 parks being studied for the Master Plan. These

statements helped to provide a unique identify for each destination within the park system. Goals and programming were also a result of these foundational mission statements.

### Goals

Goals are an important part of the master planning process because they provide structure to the vision and mission. They are objective oriented statements that help to tell the narrative while also focusing on marketing each park and realistic implementation.

### Program

The Eau Claire County park system is popular among the community for rustic and natural qualities. The existing trails are enjoyed by residents who desire to hike, snow shoe, cross country ski, bike, and horse back ride. Other notable existing program elements include:



campsites, beaches, boat landings, fishing piers, shelters, picnic areas, recreational sports courts and fields, playgrounds, and a disc golf and fitness course.

The following are important new program additions that are being proposed in the park master plans.

### **Adventure Course**

Location: Tower Ridge

Purpose: Take advantage of topography change with ropes course and zip line. Strengthen winter park use with toboggan run and ice skating loop.

### **Skills Track**

Location: Lowes Creek

Purpose: Additional bike elements will add to the identity of the park and encourage more visitors and use.

### **Dog Park**

Location: Lowes Creek Purpose: Provide an opportunity for dogs to run off leash in a controlled environment.

### **Secluded Campsites**

Location: Coon Fork

Purpose: This more private style of camping will give visitors a new overnight experience. Yurts are planned for Coon Fork.

### Accessible Canoe/Kayak Launch

Location: Coon Fork

Purpose: Accessible water access is important for inclusivity throughout the park system. A new canoe/kayak launch is proposed to allow all visitors to experience paddling.

### **Playground Upgrades**

Location: Coon Fork and Lake Eau Claire Purpose: Playground upgrades are proposed to modernize structures and provide safe and exciting play elements to the park system.

### **Interpretive Signage**

Location: Big Falls, Harstad, L.L. Phillips, and Lowes Creek

Purpose: Signage to help educate visitors on history and environmental topics will build respect and admiration for the parks.



# Park Mission & Goals



### **Mission**

One way to guarantee funding for necessary improvements is to plan ahead. To enhance the park system and ensure the ability to secure further funding in the future, it's also wise to allocate additional funding towards high-impact projects. This could include expanding camping sites and improving amenities. Additionally, because many restroom facilities throughout the park system are aging, it's recommended to include a recurring budget for restroom upgrades in the CIP. Finally, prioritizing a recurring budget for wayfinding and signage updates is also recommended. By planning ahead and ensuring these important areas are included in the budget, you'll be able to make necessary improvements while securing the necessary funding to keep your operation running smoothly.

#### Donations - Abbreviation in Matrix (DON)

Establishing a well-structured channel for donors to contribute to park improvement initiatives offers numerous benefits. Donor support can act as a vital source of funding for much-needed repairs and upgrades to park facilities, thereby enhancing the overall quality of the park experience. Though it is ideal to explore and capitalize on as many opportunities as possible, research suggests that certain improvement projects enjoy greater donor support when compared to others.

Playgrounds, pavilions, and benches are but a few examples of physical objects that invariably work well when naming rights are assigned to donors. Larger improvement projects, however, those that exceed the \$250,000 mark, require a more strategic and creative approach. By investing in a funding strategy team that typically costs approximately \$8,000, park managers can not only promote the project but also raise awareness regarding its potential benefits and significance. While such large-scale projects undoubtedly benefit from greater public exposure, they often require at least one significant contributor to ensure that they make a meaningful impact.

Furthermore, donor support can also help to build stronger partnerships between local government agencies, community groups, and private organizations, leading to more collaborative and holistic efforts in improving public spaces for the benefit of all. By engaging and involving more stakeholders in the process, park management can experience a greater sense of community engagement and participation in the improvement work. In turn, this can create a more vibrant, inclusive, and well-maintained park environment that truly enriches the quality of life within the broader community.

# Site Visit Notes (July 20/21, 2022)

## Lowes Creek County Park

This is a larger park close to Eau Claire. Overall park usage is geared heavily to trails (running and mountain biking).

Forest Management: Xeric, nutrient poor sandy out wash soils on a sizable park bisected by a narrow creek in a floodplain surrounded by steep slopes. The upland portion of the park is mostly flat. Mostly forested with a mix of pin oak, some white and red oak, red pine, white pine, jack pine, and associated species. There are some larger, healthy specimens of white spruce planted along the trails on the western side of the park. There is a very large borrow pit on the eastern side of the park abutting highway 93. It was previously used as a clay mine for fill on other projects in the county and has since been converted into a matrix of grasslands and small localized wetlands. Prairie management could be an option in this area.

Overall forest health is good although some oak wilt was noted. The oak stand in the center of the park on the east side of the creek has a mixture of over mature oak and pine that are showing signs of mortality. There are several small young stands of red and white pine, some of which overstocked and would benefit from a non-commercial thinning to promote overall health and minimize future mortality. Buckthorn was noted in the riparian zone and on the eastern side of the park. Josh said that one area had been treated once to reduce the impact of the buckthorn; this area could be considered for repeated treatments and actively managed to mitigate invasives.

Some management recommendations:

OW and mortality in large oaks is a concern for creating hazard trees; consider proactively removing infected and dying trees within the first year or two before their root base rots out and they risk falling across trails.

Prairie management in clay pit area.

Consider crowning roads and creating diversion push-outs on steep slopes on the bridge approaches to mitigate erosion issue. The park staff continues to dump bark chips on the slopes, but eventually all of that will migrate into the stream, so permanent solutions are a better long term alternative. Some minor alterations to the shape of the road surface will slow down water flow and minimize erosion.

## **Harstad County Park**

This is a smaller park on the Eau Claire River with light use, mostly confined to 27 unimproved camp sites and a canoe/kayak landing.

Forest Management: Xeric, nutrient poor sandy out wash soils covered by pine and oak. There is some basswood and intermediate tolerant hardwoods near the river. The park has planted swamp white oak and sycamore in the improved section of the park near the river.

Notes:

New playground near the river (silt fence still present).

Plans exist for a new pavilion, the original one having already been torn down.

Management has researched option to run power to the pavilion, and possibly the campground hosts' campsite. Solar was discussed as an option but dismissed to concerns about managing the batteries in the winter.

The ball field is very underutilized, so options were discussed including an archery range, large-group campsite, or walking trail (to extend around the perimeter of the park).

Restrooms could benefit from updating and improved accessibility.

The main use of the park is for the canoe landing.

Linking this park with Lake Eau Claire Park (about 2 miles) away with a non-motorized trail was discussed; easements across public land would be required and the river creates an obstacle for easy access between the parks.

Need better, clearly defined parking near the river area (canoe landing and pavilion/playground area).

## **Coon Fork County Park**

This park features a sizable campground and an 80-acre non-motorized lake with several access points for canoes and kayaks. Most management recommendations are related to these features.

The forest is young pine (red, white and jack pine) on a sandy out wash site where the previous mature jack pine had been commercially removed over 10 years ago. Forest health and vigor are good and oak wilt and other issues are minimal due to the young age class. Long term, there might be some consideration to non-commercially thin areas along trails, but no action is needed currently. The western side of the park is underutilized, especially away from the lake. There are a few trails passing through the park and connecting to county land. This might be a good opportunity to include a couple of primitive backpack-only access campsites near the lake.

Other comments:

There is a large firewood yard; encourage continued use of this to minimize risk of introducing invasives to the park by camper bringing their own firewood

Free wifi available in the campground

Park is looking for FEMA funding for a storm shelter (and trying to identify alternative uses for it to justify investment).

Park wants a garage for a ski trail groomer.

Dam and bridge are a great focal point, excellent scenery in the dells downstream.

## Lake Eau Claire County Park

This is a small park on the Eau Claire River, and is very underutilized. Predominantly used by locals, often for short visits due to nostalgia. The old main building has outlived its usefulness and is being considered for removal. It has poor air flow and is seeing reduced usage for weddings and other gatherings in recent years.

The park has large areas of grass amongst mature white and red pine and oaks, and is time consuming to maintain. Fortunately, the County's maintenance staff is based out of this park so it is logistically easier to maintain.

Recommendations and notes:

Maintain mature trees in groups to minimize risk of wind throw.

Remove trees with visible root damage (mostly due to mowing) before they become a fall hazard. Most trees are likely less than 100 years old and should still have decades remaining if they are well maintained. Some pin oak may be nearing maturity and should be removed if signs of rot are noted before they become a hazard. I observed multiple trees with swollen boles which is a common sign of advanced rot in oaks.

There is a very well-constructed fishing dock and improved rock lined shoreline with good accessibility to the river.

The very large BBQ pit near the main building is likely underutilized. Promote this site for community gatherings to take advantage of this rare amenity.

Chris and I explored the kayak portage down the road on the VFW (American Legion?) land. It was very steep with irregular steps. Although not located on parkland, the trail leading to this site extends through this park. Consider allocating resources to improving the steps down to the portage. It appears to be very underutilized.

Big question: What is the draw at this park? It needs a purpose to justify further improvements.

## **Tower Ridge Recreation Area**

This very large park is the largest in the Eau Claire County Park system, aside from the general county land system. The primary usage of this park is the extensive trail network for horseback riding and cross country skiing. There is also a privately run shooting range on the southern edge of the park below the high bluff. A local disc golf club maintains a 36-hole course on the western part of the rec area.

The park is mostly forested and ranges from a mixture of large oak, pine (white, red and jack) and associated species on the ridges and hills to oak, pine, red maple and basswood on the flood plain. Overall, the health of the pine looks good, with some notable younger jack pine and a mix of oak and pine in the northeastern corner of the park. Oak wilt is fairly advanced throughout the park, especially in the large oak that dominate the disc golf course. Buckthorn is just starting to infiltrate the park. Consider managing soon before it is too late to control its spread.

Some of the trails are lighted for night skiing, and the disc gold course doubles as a skills course for

skiing in the winter. There is a locally-organized youth ski group with a large presence on the trails on Monday nights. Parking may be inadequate if this group continues to grow. A ski chalet with restrooms and a kitchen were constructed recently and are a welcomed amenity on this park. The maintenance building was constructed by park staff and houses the ski grooming equipment and features a smaller attached garage for use by the disc golf (e.g. for storing equipment) and ski clubs (e.g. for waxing skis). Signage throughout the park is excellent and present at nearly every intersection.

Due to the nature of the public access, the eastern half of the park is less utilized than the western half (too far from the trail heads for many people). This may be an attractive feature of the park, however, if there are enough locals interested in getting away from the more densely packed activities. There is some unauthorized ATC use of the trails, but this is difficult to stop due to nearby public access points. It might be necessary to consider obstacles to adjacent property access points if damage from ATVs becomes unacceptable. Consider using water bars, diversions and crowning the slopes on the steeper sections of trail where erosion is occurring (e.g. down to the flood plain in the south).

#### LL Phillips County Park

This small park is nearly completely forested with potential for primitive camping. The oak, pine and other hardwoods on the park are in good condition. Some of the pine could benefit from thinning to maintain health and vigor.

There is a low density trail network in the park and a small open campsite/day site area in the northern part of the park. There is an opportunity to expand primitive camping options in the park and to upgrade the group site; Josh mentioned plans to build a new small pavilion on that site. The parking lot is small with ill-defined spots. Consider opening the lot more to improve visibility from the main road for law enforcement to monitor it for dumping, vagrancy, etc. Add interpretative signs to improve the accessibility and connectedness to the unique attributes of this park (especially the riparian area).

## **Big Falls County Park**

This park is well known in the county for the beautiful natural features. A new parking lot on the west side and restrooms were completed this year. The trails are scheduled to be repaved within the next year (this fall?). The eastern side is largely unimproved. Direct access to the falls is difficult off the paved paths. There was considerable discussion about creating an ADA platform to improve accessibility for the public. There should be some trail maintenance conducted on the eastern side of the park to potentially improve access from that side of the river. There are some sizable concentrations of poison ivy that might be dealt with at that time.

#### Q1 Are you a resident of Eau Claire County?






