CRIMINAL COMPLAINT

Complainant, **Petrak** on oath charges:

COUNT 1 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of INTIMIDATION, in that the defendant, with the intent to cause [REDACTED] to omit the performance of any act, namely reporting his conduct, communicated indirectly to [REDACTED] in person at her place of employment, a threat to take action as a public official, in that the defendant asked her if she had said anything to anyone about him sending pictures of his penis, that he was relieved from duty, and that if she was asked about the pictures to make a denial, in violation of 720 ILCS 5/12-6(a)(6). (Class 3 Felony). (Maximum 2-10 years IDOC; 1 year MSR; up to 2 1/2 years Probation; Maximum fine \$25,000.00) (OFT Code = 0960500)

COUNT 2 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of OFFICIAL MISCONDUCT/FORBIDDEN ACT, in that the defendant, a public officer working in his official capacity as a peace officer, intent to obtain a personal advantage of himself or another, performs an act in excess of his lawful authority, in that the defendant while on duty and in uniform solicited sexual acts and sent sexual images to [REDACTED] in violation of 720 ILCS 5/33-3(a)(3). (Class 3 Felony) (MAX 3-5 years IDOC: MSR 1 year: Fines \$25,000 or more) (OFT = 0017903)

COUNT 3 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of OFFICIAL MISCONDUCT/FORBIDDEN ACT, in that the defendant, a public working in his official capacity as a peace officer, intent to obtain a personal advantage of himself or another, performs an act in excess of his lawful authority, in that the defendant while on duty and in uniform solicited and sent sexual images to [REDACTED] and told her not to tell anyone, in violation of 720 ILCS 5/33-3(a)(3). (Class 3 Felony) (MAX 3-5 years IDOC: MSR 1 year: Fines \$25,000 or more) (OFT = 0017903)

COUNT 4 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of INTIMIDATION, in that the defendant, with the intent to cause [REDACTED] to not report his conduct, he indirectly communicated to [REDACTED] a threat to take action as a public official, in that the defendant on multiple occasions while on duty, in uniform and/or driving a marked police squad approach [REDACTED] and asked her whether or not she had told anyone about the images he had been showing and sending her and told her not to tell anyone, in violation of 720 ILCS 5/12-6(a)(6). (Class 3 Felony). (Maximum 2-10 years IDOC; 1 year MSR; up to 2 1/2 years Probation; Maximum fine \$25,000.00) (OFT Code = 0960500)

COUNT 5 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY, committed the offense of ELECTRONIC HARASSMENT/OBSCENE PROPOSAL, in that the defendant used electronic communication and made any comment, request, suggestion or proposal to [REDACTED] which is obscene with the intent to offend, in violation of 720 ILCS 5/26.5-3(a)(1). (Class B Misdemeanor) (MAX up to 6 months Jail: Probation up to 2 years: Fines up \$1,500) (OFT Code = 0016967)

COUNT 6 of 7

That on or about the 15th day of March, 2022, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of DISORDERLY CONDUCT, in that said defendant knowingly acted in such an unreasonable manner as to alarm and disturb [REDACTED] and provoke a breach of the peace, in that said defendant showed [REDACTED] a photograph of his penis, in violation of 720 ILCS 5/26-1(a)(1). (Class C Misdemeanor). (Maximum 30 days jail; 2 years Probation; Maximum fine \$1,500.00) (OFT Code = 1255000)

COUNT 7 of 7

That on or about the 25th day of September, 2021, in the County of Winnebago, State of Illinois, JEFFREY STACY committed the offense of DISORDERLY CONDUCT, in that said defendant knowingly acted in such an unreasonable manner as to alarm and disturb [REDACTED] and provoke a breach of the peace, in that said defendant showed [REDACTED] a photo of his penis, in violation of 720 ILCS 5/26-1(a)(1). (Class C Misdemeanor). (Maximum 30 days jail; 2 years Probation; Maximum fine \$1,500.00) (OFT Code = 1255000)
