**PROBATION SENTENCING ORDER**

This cause coming on for sentencing, the People present by Kyle E. Klukas, Assistant State’s Attorney of Grundy County, and the defendant present by his/her attorney,

Daniel M. Walsh and the defendant having been convicted on **JUNE 3, 2026** of the offense of **UNLAWFUL RESTRAINT (Class 4 Felony)** as filed in the Information of the above captioned case number, the defendant is hereby sentenced to:

Probation under the supervision of the Adult Probation Office for a period of **THIRTY (30) MONTHS**, said probation **to expire on DECEMBER 3, 2028**.

The conditions of probation shall be as follows:

- (1) Defendant shall not violate any criminal statute of any jurisdiction.
- (2) Defendant shall refrain from possessing a firearm or other dangerous weapon.
- (3) ~~Defendant shall not leave the State of Illinois without the consent of the court.~~

Transfer of a defendant’s probation to another state is subject to acceptance by the other state, pursuant to the Interstate Compact for Adult Offender Supervision. A transfer fee of \$125.00 must be paid to the Grundy County Circuit Clerk, prior to departure.

(4) Defendant shall report to the Probation Officer within 24 hours of the signing of this Order, either in person or by telephone at (815) 941-3266, to arrange an initial interview which the defendant shall attend in person within 7 days of the signing of this Order, and shall make such further reports of his/her whereabouts, conduct, and employment, and furnish such other information as may be required by the Probation Officer in such fashion as the Probation Officer may direct. The defendant shall also report any change of address within the State of Illinois within 48 hours of the change. The defendant shall not report to Probation under the influence of alcohol or illicit drugs.

(5) Defendant shall permit a Probation Officer to visit him/her at their home or elsewhere to the extent necessary to perform his/her duties.

(6) Defendant shall pay Fines in the amount of **\$75.00** and a Schedule 3 Assessment in the amount of **\$549.00**. Defendant shall pay a monthly probation fee in the amount of **\$25.00**, which shall be paid for each month of the supervised probation as ordered herein. **(SEE SEPARATE FINANCIAL ORDER)**

By a (Facility of choice)  (State licensed facility)  (SOMB Board facility, sex offense)

(an IDHS Domestic Violence Protocol Approved facility)  (SUPR licensed facility)

- (b) Complete the Facility's evaluation process within 45 days of today's date.
- (c) Follow all rules and recommendations for treatment that said facility shall make.
- (d) Complete at least one-half of the recommended program by \_\_\_\_\_. (6-9 month date)
- (e) Pay all costs that said facility charges; and
- (f) Complete all recommendations for treatment by \_\_\_\_\_. (12-24 month date)
- (g) Provide proof of compliance to the Probation Department

// (10) Defendant shall not consume or possess alcoholic beverages, nor shall he/she enter upon any public premises wherein alcoholic beverages are served as a primary part of that business. The defendant shall submit to alcohol testing upon the request of the Adult Probation Officer. A positive indication for any alcohol usage, failure to submit to alcohol testing, an admission of alcohol usage, or tampering with testing shall be a violation of the defendant's probation. Costs of testing are to be paid by the defendant.

/ X / (11) Defendant shall report for periodic drug testing to determine whether he/she is using illicit drugs. The frequency of these tests are to be determined by the Adult Probation Office. A positive indication for any illicit drug, failure to submit to drug testing, and admission of illicit drug use, or tampering with testing shall be a violation of the defendant's probation. Costs of testing are to be paid by the defendant.

// (12) Defendant shall maintain their employment.

/ X / (13) Defendant shall have no contact either directly or indirectly with **KAYCEE WOODWARD**.

// (14) Defendant shall not have contact and/or enter \_\_\_\_\_.

// (15) Defendant shall perform \_\_\_\_\_ of community

service work by \_\_\_\_\_ at 9:30 a.m., and shall provide proof of completion to his/her Probation Officer. Defendant shall not report to the community service work site under the influence of alcohol or illicit drugs.

/ X / (16) Defendant shall serve <sup>180</sup> ONE HUNDRED EIGHTY (120) DAYS in the Grundy County Jail. Defendant shall receive day for day credit making the actual time served <sup>Sixty</sup> SIXTY ~~(60)~~ days <sup>Thirty 30</sup> INSTANTER. The defendant shall serve an additional SIXTY (60) days in the Grundy County Jail and receive day for day credit making the actual time served THIRTY (30) days, this sentence is stayed until OCTOBER 1, 2028 and subject to a motion to vacate upon successful completion of probation.

/ X / (17) Defendant shall provide blood and/or saliva specimens to the Grundy County Sheriff's Department or to the Adult Probation Department for transmittal to the Illinois State Police DNA Bank. Said specimen shall be submitted within 45 days of conviction. The defendant shall pay a \$250.00 collection/analysis fee to the Grundy County Circuit Clerk.

**(WAIVED IF PREVIOUSLY SUBMITTED)**

/ / (18) Defendant shall provide blood and saliva specimens at a facility of the Adult Probation Department's choice within 36 hours for HIV and STD testing, and said test results shall be made available to the Adult Probation Officer. Defendant shall conform with all statutory requirements of the Sex Offender Registration Act and any other Act relating to sex offenders.

/ X / (19) Defendant shall physically surrender his/her Firearm Owner's Identification Card to the Grundy County Circuit Clerk, Grundy County Courthouse, and any and all firearms in his/her possession to the Grundy County Sheriff, within 7 days of the date of this order. Should the defendant come into possession of either in the future, he shall immediately surrender them

to the agency directed above.






