On 7/12/23 at 1434 hrs I, Ofc. D. Stone #120 was dispatched to the Village of North Aurora Village Hall to speak to the Village	
Community Development Director: Darga, Nathan. Nathan and other Village Building Department employees stated that they were	e in
contact with the owners of a newly built home in Moose Lake Estates (The new owner: inquired about	ut
a pool permit for the construction of a pool at his new home. Building Department employee's were confused because a Certificate of	of
Occupancy (C.O.) was not issued for anyone to be in the home yet. was able to provide a Certificate that was given to him at	the
closing for the new home on 7/7/23. A Certificate of Occupancy was not issued by the Village due to multiple issues still found by	
inspectors. Nathan said these issues would not cause harm to an individual or the family of the new occupants.	

Upon review of the provided certificate Nathan and the other employees determined that the certificate was forged. They believe an employee of McCue Builders forged the document to allow the homeowner to move in. The employee of McCue Builders that the Village deals with is Michels, Sean. Correspondence with McCue Builders was made via email regarding some of these issues which leads Nathan to believe that McCue Builders was aware that the Village did not issue a valid C.O. A copy of the email will accompany the written report.

Nathan also provided documentation which shows that the C.O. that the homeowner provided was forged. For example: 1. The village uses a different format for a zip code. The C.O. had the zip:60542 when the standard format is 60542-1798. 2. The permit number was wrong. The permit number used on the forged C.O. loosely resembles the permit number from another property which was a McCue Builders project. In addition to the incorrect permit number, it did not end with -SFH1 which is a standard format. 3. The lot number portion of the forged C.O. is wrong. 4. The date format is wrong on the forged C.O. The Village program generates every month in 3 characters (Jan, Feb, Mar, etc). The month on the C.O. shows July instead of Jul. Nathan provided a detailed example of the errors on the forged C.O and provided examples of valid C.O.'s. In addition to the errors Nathan advised that the Village Building Official: Zabel, Paul did not work a full day on July 3rd and could not have signed the document. It is believed that his signature was copied and pasted onto the document and not formally signed.

Nathan and the Building Department employee's advised there are several reasons why a builder would forge this document but at this time it is not determined what the reason is. Nathan reiterated that the residence is safe for occupancy and all the builder needed to do was request a temporary C.O. which the Village would have issued for the residents to move in.

Nathan, on behalf of the Village, is requesting investigation of the forgery.

All provided documentation will accompany the written report.

On 7/12/2023 The Community Development Director for North Aurora,	Nathan Darga, became aware of a forged
document, the Certificate of Occupancy for	Darga was alerted when the
homeowner, wanted to acquire a pool permit but shouldn'	t be living at the property.
Certificate of Occupancy that he was given to Darga.	

Darga reviewed the document and alerted to several issues: the Zip code was in the wrong formatting, the permit number was wrong, the lot number portion is wrong, and the date format is wrong. Darga also reviewed their system and determined that no Certificate of Occupancies were issued on July 3, 2023. Darga also spoke with the remaining people at Village Hall that had access to the system, and they confirmed they did not issue the Certificate of Occupancy. Darga also reported that Michels, Patrick S (M/W 10/23/1963), was who they dealt with from McCue Builders when dealing with permits.

On 7/13/2023 I, Det. Kyle Jensen #124, spoke with Frank. He stated that he was not aware that the Certificate had been forged. Frank, after speaking with Axen Mortgage, was able to find an email that showed he received it from Wheatland Title Company. The email, that had the attached forged certificate, had been sent from Susan Baker from Wheatland Title on July 7, 2023 at 12:59:18 PM. The message included with the email was that she just received the Certificate of Occupancy from the Builder and that it was attached.

On 7/14/2023 I spoke with Susan Baker from Wheatland Title she stated she had the email where they originally received the forged Certificate of Occupancy but would need a court order to release it. Susan did state that Michels was who they dealt with from McCue Builders when working with permits.

On 7/17/2023 I obtained a search warrant for Wheatland Title. Wheatland Title then provided with the email from "mccuebuilders@comcast.net" that was sent on July 7, 2023 at 12:55PM. The message stated that attached was the occupancy permit for the Frank's closing and had "Sean Michels" in the footer of the email. The email also showed this was in response to an email sent from Susan Baker on 7/7/2023 at 08:13 AM when she emailed

"mccuebuilders@comcast.net" asking Sean for the Certificate of Occupancy.

On 7/17/2023 I went to the listed address from the McCue Builders website, 533 Mooselake Ave North Aurora, Kane County, Illinois. I spoke with Kathy, the Office Secretary. Kathy confirmed that Michels dealt with permits and no one else from McCue Builders does. Kathy stated that the "mccuebuilders@comcast.net" is the email that Sean uses and no one else does from the Office.

On 7/18/2023 I spoke with Michels who denied all knowledge of the forged Certificate of Occupancy permit.

Michels was not able to provide an explanation to who would have sent the Certificate of Occupancy.

I called the On-Call ASA and spoke with ASA Norkus. Charges for Forgery Makes or Alters Document - 720 ILCS 5/17-3(a)(1) and Issue or Deliver Forged Document - 720 ILCS 5/17-3(a)(2).
