7.03 School Maintenance Project Grant (SMPG)

Motion:

Motion to approve the School Maintenance Project Grant (SMPG) as presented.

Background Information:

The **School Maintenance Project Grant (SMPG)** is a dollar-for-dollar state matching grant program that provides awards of up to \$50,000 to grantees exclusively for the maintenance or upkeep of buildings or structures for educational purposes. Approximately \$40 million is available for the FY26 SMPG. All project activities must be expended or legally obligated within two years of disbursement by the State.

The State has identified five purposes for awarding the SMPG in the following order of priority:

- A) Emergency Projects are projects made necessary by a disaster
- B) Health/Life Safety Projects are projects to remodel or improve an existing structure to correct a violation of the Health/Life Safety Code for Public Schools
- C) State Priority Projects are projects necessary for energy conservation or that adapt a building or structure to better serve students in a specific program
- D) Permanent Improvement Projects are projects designed to

upgrade or install building systems

E) Other projects do not fit in any above categories.

The school administration would like to apply for a grant to help offset the costs associated with purchasing and installing new boilers at Yorkville Intermediate School.

The district anticipates completing this project in early fiscal year 2027.

Timeline:

Deadline to Submit Application to ISBE January 30, 2026

Financial Impact:

The estimate for this project will exceed the \$50,000 needed to optimise the full matching capabilities of the grant.

7.04 Proposed - Election Resolution

Motion:

Motion to approve the Resolution providing for and requiring the submission of the proposition of issuing \$275,143,683 School Building Bonds to the voters of the District at the general primary election to be held on the 17th day of March, 2026.

Background:

Following a comprehensive Facility Master Plan process driven by increasing enrollment and aging infrastructure, the District has identified critical needs to maintain educational quality for Yorkville School District 115.

District officials, in collaboration with the community steering committee, have determined that a referendum is necessary to fund these improvements. The administration has worked with Bob Lewis (PTMA) and Anjali Vij (Chapman and Cutler) to develop the funding structure and the precise legal language required for the ballot.

The proposed scope of work includes:

- Construction of two new school buildings to address capacity.
- Additions to Yorkville High School (Academic Wing, Performing Arts Center, Fieldhouse).
- District-wide safety, infrastructure, and mechanical updates.

"Shall the Board of Education of Yorkville Community Unit School District Number 115, Kendall and Kane Counties, Illinois, build and equip two school buildings; build and equip additions to the Yorkville High School Building, including construction of an academic wing, a performing arts center, and a fieldhouse; alter, repair and equip existing school buildings and facilities, including construction of

additional classrooms and teacher and student support spaces, and improvements to safety, infrastructure and mechanical systems; improve school sites; and issue bonds of said School District to the amount of \$275,143,683 for the purpose of paying the costs thereof?"

Timeline:

- December 15, 2025: Board of Education votes on Referendum Resolution
- January 8, 2026: File the Referendum Resolution with Kendall and Kane County Clerks
- March 17, 2026: Illinois General Primary Election

Financial Impact:

If approved by voters, the District will issue bonds totaling \$275,143,683.

Based on current market conditions estimated by PTMA:

- Impact on Homeowner: For a home with a Market Value of \$323,700 (the district median), the estimated tax impact is \$577 annually.
- Monthly Breakdown: This equates to approximately \$48.08 per month.
