**ORDER
(WITH POST-RELEASE SUPERVISION)**

Came on this cause this day for hearing, the defendant being before the Court in person and with his/her attorney Honorable **ANTHONY L. FARESE** said defendant being before this court on a **REDUCED** charge of **SECOND DEGREE MURDER** on indictment against him/her and having entered a plea of not guilty to said charge on a former day in this Court, defendant, **TIMOTHY ALBERT TURNER, II** withdraws his/her former plea of not guilty and enters a plea of guilty as charged, said plea is accepted by the Court, the Court finding that said plea is voluntarily and understandingly entered by the Defendant.

IT IS THEREFORE ORDERED AND ADJUDGED by the Court that the Defendant be and he/she is hereby sentenced to serve a term of **FORTY (40)** year(s) in the custody of the Mississippi Department of Corrections at a facility to be designated by said department and that **TEN (10)** year(s) of said sentence shall be and the same is hereby suspended and the defendant shall be placed under Post-Release Supervision upon the release from the term of incarceration for a period of **FIVE (5)** year(s), pursuant to Mississippi Code Sec. 47-7-34, and the suspension of said sentence is based upon the following conditions:

- (a) Defendant shall hereafter commit no offenses against the laws of this or any other state or the United States;
- (b) Defendant shall avoid injurious or vicious habits;
- (c) Defendant shall avoid persons or places of disreputable or harmful character;
- (d) Defendant shall report to the Department of Corrections, as directed by it;
- (e) Defendant shall permit the Field Officer to visit him/her at home or elsewhere;
- (f) Defendant shall work faithfully at a suitable employment so far as possible;
- (g) Defendant shall remain within a specified area unless authorized to leave on proper application therefore;
- (h) Defendant shall support his/her dependents;
- (i) Defendant shall hereby waive extradition to the State of Mississippi from any jurisdiction in or outside the United States where he/she may be found and likewise agree that he/she will not contest any effort by any jurisdiction to be returned to the State of Mississippi;
- (j) Defendant shall pay to the Department of Corrections a supervision fee monthly by "certified check" or "money order" until discharged from supervision, per Mississippi Code Section 47-7-49 Annotated.
- (k) Defendant shall not possess or use any alcoholic beverages, illegal drugs, narcotics, mood altering substances, or any substances controlled by the law which are not prescribed for him/her by a physician;

- (l) Defendant shall not possess any firearm or other deadly weapons as defined by state law during this term of probation;
- (m) Defendant shall submit, as provided in Section I of House Bill 354, 1983, Regular Session, to any type of breath, saliva, or urine chemical analysis test, the purpose presence of alcohol or a substance prohibited or controlled by any law of the State of Mississippi or the United States, and shall pay a fee for each positive urine analysis;
- (n) Defendant shall attend and complete any special programs or counseling as directed by the Court or Field Officer and pay any fees as required for services;
- (o) Defendant is ordered to pay Court Cost in the amount of \$431.50 and a Fine in the amount of \$1,000.00 to be paid at a rate of \$_____ per MONTH until paid in full, first payment being due on _____ and following payments on the same date of each MONTH to be paid to the Circuit Clerk.
- (p) Defendant is ordered to pay assessments is in the sum of \$200.00 to DISTRICT ATTORNEY'S OFFICE (investigative fee) and \$200.00 to TUPELO POLICE DEPARTMENT (investigative fee) and \$100.00 to MS CRIME VICTIMS COMPENSATION FUND to be paid following payment of fine and cost and to be paid at the same rate.

And further, that THE IMPOSED THIRTY (30) YEARS ARE TO BE SERVED DAY FOR DAY. THE DEFENDANT IS TO RECEIVE CREDIT FOR ANY AND ALL TIME SERVED ON THIS CHARGE. THE DEFENDANT IS REMANDED TO THE CUSTODY OF THE LEE COUNTY SHERIF'S DEPARTMENT TO AWAIT TRANSPORTATION TO SAID FACILITY.
