INDICTMENT

The Grand Jury charges that:

COUNT ONE

From on or about October 14, 2022, to on or about October 17, 2022, in the Northern District of Mississippi, JARED SHEMAR HANNAH, defendant, did knowingly possess a machinegun, as that term is defined in Title 18, United States Code, Section 921(23) and Title 26, United States Code, Section 5845(b), that is, a Glock, model 17 Gen4, 9x19mm caliber firearm with a Glock-type fully automatic conversion device and extended capacity magazine, all in violation of Title 18, United States Code, Sections 922(o) and 924(a)(2).

COUNT TWO

From on or about October 14, 2022, to on or about October 17, 2022, in the Northern District of Mississippi, the defendant, JARED SHEMAR HANNAH, knowingly possessed stolen firearms, which had been shipped and transported in interstate commerce, knowing and having reasonable cause to believe the firearms were stolen, including one or more of the following firearms, to wit: a Glock, model 17 Gen4, 9x19mm caliber firearm; a Glock, model 19 Gen5, 9mm caliber firearm; and a Radical Firearms, model RF-15, 5.56mm rifle. all in violation of Title 18, United States Code, Sections 922(j) and 924(a)(2).

firearm and a Radical Firearms, model RF-15, 5.56mm rifle.
