**INDICTMENT**

The Grand Jury charges that:

**COUNT ONE**

On or about April 1, 2022, in the Northern District of Mississippi, KENNY PAUL GENO, defendant, did use, persuade, induce, entice, and coerce any minor (hereinafter referred to as Minor Victim 1) to engage in sexually explicit conduct for the purpose of producing any visual depiction of such conduct knowing and having reason to know that such visual depiction would be transported using any means and facility of interstate and foreign commerce, and using materials that were mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2251(a) and (e).


**COUNT TWO**

From on or about January 1, 2023 until on or about September 1, 2023, in the Northern District of Mississippi, KENNY PAUL GENO, defendant, did knowingly use a facility or means of interstate commerce, to persuade, induce, and entice, and attempt to persuade, induce, and entice a minor, M.V. 2, who had not attained 18 years of age, to engage in sexual activity with KENNY PAUL GENO, for which sexual activity KENNY PAUL GENO could be charged with a criminal

offense, that is, Sexual Exploitation of Children, in violation of Title 18, United States Code, Section 2251(a).

In violation of Title 18, United States Code, Section 2422(b).
