

AFFIDAVIT OF COMPLAINT

Personally appeared before me Cameron Jones #13657 and made oath that on or about the 24th day of December, 20 23, in said County, and within the jurisdiction of the Criminal Court of Shelby County, Tennessee, one William Strohm, age 47, sex Male, whose last known address is At Large, Memphis, TN 38134, did unlawfully commit the offense(s) of Disorderly Conduct (T.C.A. 39-17-305), Evading Arrest (T.C.A. 39-16-603) and the essential facts constituting said offense(s) and the source of the affiant's information are as follows: KR

On 12/22/2023 at 17:00 hours, Officer D. Osborn (12154) responded to a Disorderly Conduct at 5158 Summer Ave.

Officers Osborn 881c and Dolan 871c received an armed party call to the ExxonMobil at 5158 Summer Ave from a caller who refused to speak, they advised that they were working for the US Marshall's, and they were observing an Escapee from Mississippi, suspect William Strohm, sitting with a female white with purple hair at this location. The unknown caller advised that the subject was possibly armed with a gun, and that the suspect would run.

Officers made scene at 1543hrs and found the suspect sitting on the west side of the business with 3 other individuals, that included an unknown female with purple colored hair. Officers made contact with the suspect who advised he didn't have any identification. He was instructed to stand up to which he complied. Before Officers could place hands on the suspect, he took off running southbound across Summer Ave almost being struck by passing motorists. The suspect refused to stop, and he proceeded to jump into a storm drainage ditch and run eastbound in the ditch. Officers were cutoff by a fence, and an initial perimeter was started. Other officers and units made the scene to assist with the search, including the air unit and kilo unit.

After a lengthy search, 6813 Officers Bulak and Vineyard located the suspect hiding between the retaining wall on I40w before Summer Ave exit, and he was unresponsive. Officers requested the fire department and for naran. 6819 brought naran to the scene, and 6813 began administration at 1642hrs. At 1645hrs he was administered a second dose for a total of 8mg. The suspect became responsive shortly after the last dose. The suspect had minor scratches and lacerations to his face and hand from climbing fences and running through brush and trees. MFD unit 29 and Engine 51 made the scene. 806c Lt O. Hertz made the scene and was advised. 6813 road with the ambulance to Baptist East Hospital with the suspect who was in non-critical condition.

The suspect William Strohm's warrant was verified on Station B, and the suspect would be transported to 201 Poplar Ave after being medically cleared from the hospital. 6813 tagged the naran under 2312028821me memo. It was undetermined when the suspect ingested the unknown drugs. These events occurred in Shelby County, Tennessee.
