RECOUNT PETITION

In Re: The Election for
LA CROSSE COUNTY SHERIFF

Verified Petition for Recount

Petitioner FRITZ LEINFELDER alleges and shows to THE LA CROSSE COUNTY
CLERK, GINNY DANKMEYER:

1. That Petitioner was a candidate for the office of LA CROSSE COUNTY SHERIFF in an election held on November 8th of 2022;
2. The Petitioner is an aggrieved party as defined in Wis. Stat. § 9.01(1)(a)5 (the total votes were 27,373 to 27,198 pursuant to the official results promulgated by the La Crosse County Clerk for a 175 vote difference which is approximately 0.32%).
3. That Petitioner is informed and believes that a mistake or fraud has been committed in CITY OF LA CROSSE WARDS 3, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, & 18 in the counting and return of votes cast for the office of LA CROSSE COUNTY SHERIFF; and/or
4. That Petitioner is informed and believes and/or knows of his own knowledge that:
 1. On information and belief, ballots were issued to electors and those ballots were voted by individuals who were not qualified electors under Wis. Stat. § 6.02 and/or Wis. Stat. § 6.03.
 2. Absentee ballots were issued and absentee ballots were counted which were legally insufficient including but not limited to because they were not valid absent electors under ch. 6 of the Wisconsin Statutes, because the absentee ballot requests and/or the envelopes that they were returned in were technically deficient, and because, on information and belief, some of the purportedly absent electors failed to meet the criteria established under Wis. Stat. § 6.02 and/or 6.03.
 3. On information and belief, some ballots that were voted for Fritz Leinfelder are believed not to have counted for Fritz Leinfelder due to voters not completely filling in the bubbles even though the voter intent is believed to have been clear from the ballot such that a hand count would clearly reveal the voter intent.
 4. On information and belief, pursuant to the Wisconsin Statutes, including but not limited to Wis. Stat. § 6.55 and 6.56, some electors were improperly registered,

including but not limited to without sufficient identification and therefore should not have been allowed to register and vote.

5. The Petitioner reserves the right to amend and/or supplement this Petition pursuant to Wis. Stat. § 9.01(1)(a)4.

Wherefore: Petitioner requests a recount of CITY OF LA CROSSE WARDS 3, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, & 18 .


