I arrived at I located a small goat (either a small breed of goat or a baby goat) on the roadway in front of the residence. The goat was frozen and missing it's head.

I was unable to locate any blood the area, suggesting that the head was severed elsewhere and the body was allowed to freeze prior to being placed in the roadway.

I made contact Dora Alvarez-Roa. She advised me that she located the dead goat while preparing to leave the house. After consulting with her family, she believed that the goat was left there sometime between 0730 and 0830, as it was not there when her son-in-law left for work.

I took photos of the goat and surrounding area.
