

NARRATIVE

In late May, 2025, in the County of Yakima, State of Washington, at 1271 Deeringhoff Road, Moxee, WA, 98901, Jeffrey Burkett allegedly committed the crimes of RCW 9A.44.060 Rape in the Third Degree and RCW 9A.36.041 Assault Fourth Degree with Sexual Motivation.

On 06-03-25 [REDACTED] 71 came in to the Sheriff's Office to talk to Detective Arreguin. During the interview [REDACTED] 71 explained that she has been [REDACTED]

[REDACTED] 71 said on several nights, beginning on about 05-21-25, Jeffrey had touched her while they hung out in the living room after everyone else had gone to bed. She explained the first time it happened, Jeffrey hugged her and she wrapped her legs around his waist [REDACTED] 71 said on 05-26-25, Jeffrey again hugged her and eventually she ended up on his lap as they sat face to face [REDACTED] 71 said Jeffrey later touched her between the legs and "masturbated" her over the shorts she was wearing [REDACTED] 71 said as this happened, she froze up and laid there scared. She estimated that Jeffrey had touched her for about ten minutes. [REDACTED] 71 said she never told Jeffrey "no" and didn't know what he would've done if she had said it.

[REDACTED] 71 talked about another incident, which she believed occurred on the night of 05-31-25. [REDACTED] 71 said she and Jeffrey were hanging out in the living room again after everyone had gone to bed [REDACTED] 71 said this time, Jeffrey was talking about sexual things. She said she got up to go to bed, but Jeffrey hugged her [REDACTED] 71 said that at that time, Jeffrey was pressing his "boner" against her and asked if she wanted to touch it. [REDACTED] 71 said she responded "not really". [REDACTED] 71 said she felt like she didn't have control of the situation, so she took her shirt off. [REDACTED] 71 said Jeffrey touched her face and her breasts, but she jerked away and put her shirt back on.

[REDACTED] 71 said Jeffrey leaned her over the couch and took her shorts down while they stood. [REDACTED] 71 explained Jeffrey touched her through her underwear, but ultimately just took the underwear down. She continued and said that Jeffrey leaned her onto the couch and began performing oral sex on her "twice" over the course of a few minutes. [REDACTED] 71 said Jeffrey asked her if she wanted to touch his "dick" but she didn't respond because she felt like anything she said or did wouldn't matter. [REDACTED] 71 said Jeffrey grabbed her hand and put it on his penis but her hand went limp.

71 said Jeffrey inserted a finger inside of her and made a comment about how tight it was. She said Jeffrey took out his "dick" and put it inside of her about an inch. 71 said Jeffrey made a comment about it being difficult because it was so tight. She explained that Jeffrey masturbated for about five minutes, where he ejaculated on her stomach. 71 said after this, Jeffrey threw a tissue at her and said "If you tell anyone about this [REDACTED] [REDACTED] said she used the tissue to clean herself off and balled it up and threw it away in the trash.

71 said she didn't tell Jeffrey "no" at any time because she was "freaking out". 71 said she debated punching Jeffrey in the testicles so that she could get away.


The family members of the household were all interviewed. No one else was witness to any assault. Jeffrey had retained legal counsel, and therefor did not provide a statement. There was no physical evidence collected for the case. At this time, it is requested the case be reviewed by a prosecutor.
