Brief Factual summary of the occurrence:

Criminal allegations of sexual assault were filed by a citizen alleging that Chief of Police Jeff Burkett raped her. This was alleged to have occurred while Chief Burkett was off duty. Chief Burkett was placed on administrative leave. During this time several incidents of alleged misconduct arose. The Yakima County Sheriff's office is investigating the criminal allegations and will be forwarding their findings to the Yakima County Prosecutor. At the time of this report the investigation in on going and we have not been provided any reports. Yakima Police Department agreed to conduct the administrative investigation. The City of Moxee received this report on August 12, 2025. During that administrative investigation there were several findings of misconduct. The City has moved forward with a pre termination hearing.
