Under Federal Rule of Civil Procedure (FRCP) 68, Defendant City of Yakima (City) hereby offers to allow judgment to be entered against it in this action for:

- 1. Plaintiff's past response costs incurred through November 1, 2022, in the amount of \$295,000, plus prejudgment interest. This amount includes Plaintiff's attorney fees and costs incurred through November 1, 2022.
- 2. A declaration of liability for future response costs incurred by Plaintiff at the Interstate 82 Exit 33A Yakima City Landfill Site that are not inconsistent with the National Contingency Plan, including reasonable attorney fees as provided by statute.
 - 3. The City specifically reserves its rights of appeal.

This offer of judgment is made to compromise a disputed claim and for the purposes contemplated by FRCP 68; it shall not be construed as an admission either that the City is liable in this action or that Plaintiff has incurred recoverable response costs. This offer of judgment is intended to resolve all of Plaintiff's claims in this action. The amount offered reflects the total costs tendered by Plaintiff to the City as of the date of this offer.

To accept this offer, Plaintiff must serve written notice of acceptance within fourteen (14) days of the date this offer is made. If Plaintiff does not accept this
